### **CITY COUNCIL MEETING RE-CAP – NOVEMBER 15TH, 2022**

**CONSENT ITEMS:** City Council approved 9 Consent Agenda Items including:

- **12.5:** City Council approved \$2.67 million in Community Support Grant Program funding for 35 local organizations and nonprofits. Funded projects will benefit youth housing, education, employment, and recreation; community/youth well-being; homeless support and outreach; food distribution; workforce development; and arts & culture. The funding was provided to the city by the American Rescue Plan Act (ARPA), allowing for the continuation of successful programs and the development of new programs.

- **12.9:** City Council approved acceptance of the Bureau of Justice Assistance Local Law Enforcement Crime Gun Intelligence Center Integration Initiative (CGIC) Grant in the amount of \$700,000.

The Stockton Police Department (SPD) proposes to use the CGIC project funds to combat violent gun-related crimes and strengthen the efforts of the crime evidence team in capturing pertinent data regarding guns used in violence within the City of Stockton. In addition, SPD, along with their ATF partners will utilize intelligence, technology, and community engagement to swiftly identify unlawfully used firearms and their sources, and effectively prosecute perpetrators engaged in violent crime.

**NEW BUSINESS:** City Council received informational updates and/or acted on 2 new business items including:

- **15.1:** City Council awarded a professional services contract to Revize Software Systems, LLC for the redesign, development, implementation, hosting, and maintenance of the City of Stockton website. This project will provide enhanced customer service and increase community engagement through improved access to information about City programs, projects, services, news, and events.

Improvements include:

1. A state-of-the-art website design that is visually appealing with user-friendly navigation, designed for mobile-phone use as well as computer/tablet, and includes third-party applications integration.
2. Community engagement and accessibility will be increased through enhanced customer service channels, ADA compliance, language translation features, and cyber-secure hosting and connectivity.
3. This solution provides training, support, and reliability for our department website content providers; delivers analytics to evaluate and improve the website and optimize searches; and can be customized with City specific colors, branding and preferred features.
